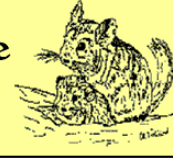

31st East Westphalia Show on October 25, 2025

International Chinchilla Show

Location: Bürgertreff St. Lucia – Michelnhöfe 2 – 59519 Möhnesee
Admission from 8:00 a.m.

The **East Westphalia Show** will be held solely as an animal evaluation event.

Please print **two copies** – only **color printouts** will be accepted.

Your online registration by October 17, 2025 will help us organize the event.

Event Schedule:

Animal Check-in 8:00 a.m. - 10:00 a.m.

Color classification and judging from 10:00 a.m.

Lunch snack at approximately 1:00 p.m. – **Registration** at the Animal Check-in until 10:00 a.m.!

Continuation of the evaluations

2:00 p.m. to 5:00 p.m. – Raffle ticket sales

Coffee break around 4:00 p.m.

Distribution of raffle prizes

Continuation of the remaining evaluations

After approval by the show management: Inspection of the animals

Followed by **dinner** – registration lists at the animal reception until 2:00 p.m.

Exhibitors' catering

During the day, you will receive all kinds of drinks, breakfast, a lunch snack, and coffee and cake at the counter.

The exhibition is intended to be a private event. Therefore, we attach great importance to introducing ourselves to one another and providing visitors' addresses along with all the information on the registration form. Data protection is, of course, guaranteed.

Whereabouts of the animals:

Only animals that have been accepted for evaluation by the animal reception are allowed in the exhibition premises.

Animals that may be eliminated before judging can be housed in an adjoining room. Please ensure that no animals are left on the floor.

The animals can remain in the hall overnight into Sunday.

For those arriving on Friday, animals can be housed in the hall from 6:00 PM to 8:00 PM.

Please remember to care for the animals!

Tender:

Animal Arrival:

Saturday, October 25, 2025, 8:00 AM to 10:00 AM, **registration** in the hall.

We ask our guests to adhere to the time limits, as approximately 1.5 hours should be available for inspection and distribution after the animal judging.

The animals will be judged by the E.P.V.C. judges.

The start time will be announced by the show management.

The awards ceremony will take place after the show.

Entry Fee:

We charge a fee of €18 for 1 to 3 animals, and €6 for each additional chinchilla.

Exhibitors must bring their own display cages. Prepared cages may be rejected.

Rental cages are available in exceptional cases. A €3 deposit is required per cage. Upon return, €0.50 will be retained to cover costs.

Admission for visitors not exhibiting animals is €6.00 - children are free.

Conditions of Participation:

Exhibition animals must be healthy. Obviously sick or abnormally well-bred animals will be rejected upon entry.

Any manipulation of the exhibition animals at any stage of judging may lead to disqualification.

The entry fee is non-refundable.

Please do not mark the exhibition animals with ear tags, tattoos, or other markings!

The judges' decisions cannot be appealed.

No liability is assumed for the exhibited animals. Legal recourse is excluded.

Corrections to cage labels cannot be made after the animals have been handed over.

By signing the registration form, the exhibitor accepts the above conditions.

Group allocation:

Standard	4 + 5 months, 6 + 7 months in comparison without distinction by sex. From 8 months, scoring without distinction by sex.
Mutations	4 + 5 months, 6 + 7 months in comparison without distinction by sex. From 8 months, scoring without distinction by sex.
Angora	4 + 5 months, 6 + 7 months in comparison without distinction by sex. From 8 months, scoring without distinction by sex with

new Angora card.

Locke	4 to 7 months, from 8 months - all animals in comparison

Color classes: Standard: medium, medium/dark, dark, and extra dark.

Mutations: color assignment is determined by the judges.

The group size must be at least 3 animals. If this is not the case, the animals will be placed in a color-similar, age-matched group.

Prizes:

Standard

Comparison	4 + 5 months – the 1st + 2nd winner of the young animal is determined from all 1st prizes. 6 + 7 months – one color class winner in each color class, from which one show winner is determined.

Points: one color class winner from each color class, from which – from 50 points – a light show winner, and from 55 points – a dark show winner.

Mutations

Comparison	4 + 5 months – the 1st-4th winner of the young animal is determined from all 1st prizes. Young Winners Determined 6 + 7 months – one color class winner per color class, from which a 1st + 2nd Show Winner is determined

Points from each color class – at least 42 points are used to determine the 1st + 2nd Show Winner (light) and the 1st + 2nd Show Winner (dark)

Black Velvet 6 + 7 months in comparison: one Black Velvet Young Show Winner
from 8 months, one Black Velvet Over 8 Show Winner

Angora

Comparison: 4 + 5 months – the 1st and 2nd Young Winners are determined
From all 1st prizes.
6 + 7 months – one color class winner per color class, from which a 1st and a 2nd Show Winner
No color class winner

Points one color class winner from each color class – from which a 1st + 2nd Show Winner is determined

Locke

All in comparison - one price out of all

Farm Winners:

1st + 2nd Standard Winning Farm – 10 animals from the comparison and 5 animals from the scoring system

1st + 2nd Mutation Winning Farm – 10 animals from the comparison and 5 animals from the scoring system

The following additional points are included in the calculation for determining the Farm Winner:

Each color class winner: 2 points

Each young animal winner: 3 points

Each show winner: 4 points

Each exhibitor receives a certificate

According to the Veterinary Office, an animal fair requires a permit, which is required when animals are offered for sale, bought/sold, or exchanged. (According to Section 11 Paragraph 1 No. 7 of the Animal Welfare Act.)

The association therefore points out that these activities must be avoided in the rented premises and during the event.

Furthermore, the association points out that photos of animals and visitors – including cell phone photos – may only be taken with the permission of the show management!

By signing the registration form, the exhibitor confirms that they will comply with the conditions and are personally liable for any violations.
